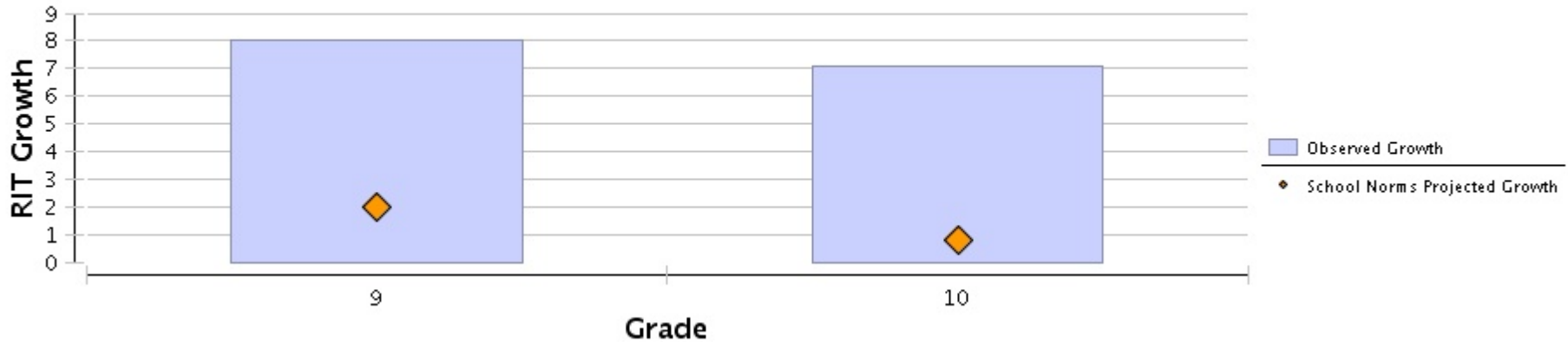

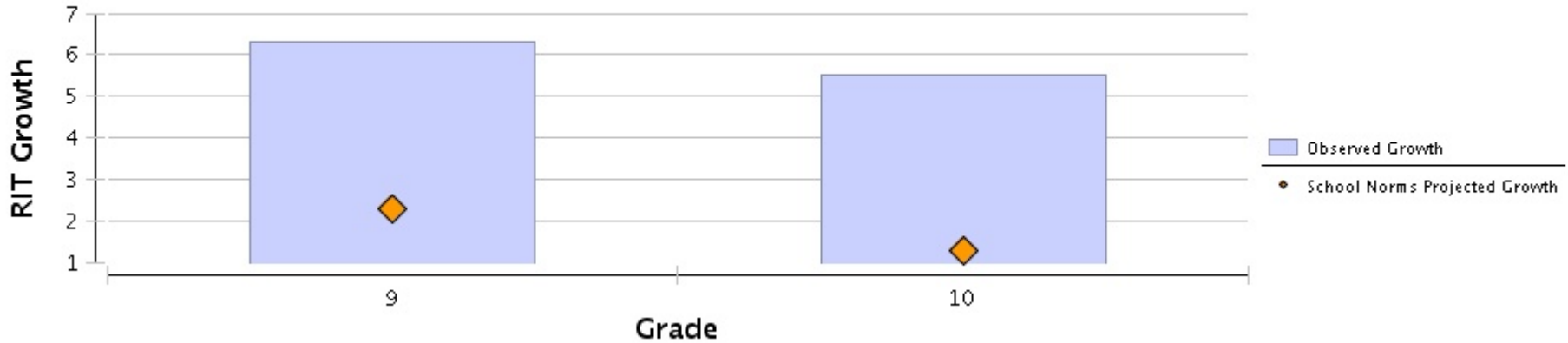

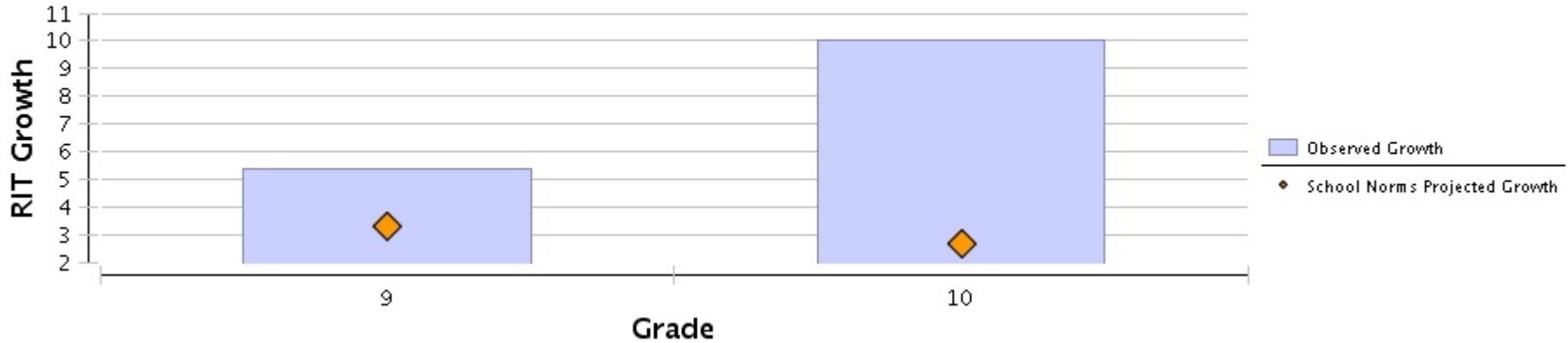

- b. Approval of the Annual Organizational Items Resolution
A motion was made by Mr. Gavan and supported by Mr. Lemoine to approve the Annual Organizational Items Resolution as discussed:
